# **QUALIFICATIONS FOR MEMBERSHIP**

A sole Proprietorship, or a Partnership or an Association of Persons or a Body Corporate or a Multinational Corporation or a Service concern shall be eligible for the membership of the Lahore Chamber of Commerce and Industry, such a firm or company is being assessed for the purpose of income tax or sales tax if applicable at Lahore or has its head office, registered office or manufacturing concern located in the Lahore district.

### CORPORATE MEMBER

This class of membership shall be open to all industrial and commercial undertakings either a body corporate or a multinational corporation with its head office or branch office in Pakistan or a sales-tax-registered manufacturing or a sales-tax-registered business concern having annual turnover of Rs. 50 million or above.

## ASSOCIATE MEMBER

This class of membership shall be open to medium and small industrial and commercial undertakings, which are not a body corporate or a multinational or a sales Tax registered manufacturing concern or a sales-tax-registered business concern having annual turn-over Rs. 50 million or above.
