- Each application for Export Trophy for various categories / items, should be accompanied with the payment in the form of Bank Draft/Pay Order drawn in favour of the Lahore Chamber of Commerce & Industry (LCCI);

- Each applicant shall submit detailed statement showing Volume of Exports / Services along with the prescribed application form duly filled in completely for the period 2015-2016 authenticated and verified by the concerned bank(s). The application should be supported by the following documents:
 - Lahore Chamber Application Form duly filled-in.
 - Bank Certificate duly attested by two Bank Officers (applicable to export / service related applicants).
 - Lahore Chamber Export Trophy Pro-forma duly attested by the concerned bank(s) (applicable to export / service related applicants).
 - Application fee through Demand Draft / Pay Order favouring "The Lahore Chamber of Commerce & Industry (LCCI)" (for all Applicants).
 - Form "E" (on requisition/demand, if necessary).
 - Bill of Lading (B/L) (on requisition/demand, if necessary).
 - The Export Trophy shall be received by the Chairman, Chief Executive, Managing Director, Proprietor or Director or a person duly authorized to receive the award of the Company.
 - Selection of Trophy Winners will be made by the Export Trophy Selection Committee of LCCI.
 - If a company fails to complete all the requirements of the trophy, LCCI has the right to reject or accept the application under prescribed category by the approval of Trophy Committee of LCCI.
 - Once the selection for the trophy is made or the letter of selection is issued to the company, the entire amount deposited will become non-refundable under all Circumstances.
 - The decision of the LCCI Trophy Committee with regard to the selection of Trophy Winner shall be final and binding on all concerned and it shall not be challengeable/ Contestable in any Court of law.
 - The LCCI reserves the right to demand any further proof regarding the documents submitted in support of the claim of the trophy.
 - The LCCI reserves the right to make any amendment, alteration or revision in these Rules & Regulations, any time whenever deemed necessary.
 - The last date of submitting the application is 20th August 2017.
